In the very near future, You will not be able to engage in Hearth Professional Work Unless Licensed as a NJ "Master Hearth Specialist"

What is a NJ Licensed, "Master Hearth Specialist" ?

"Licensed Master Hearth Specialist" means a person who holds a current, valid license to engage in "Hearth Professional Work" pursuant to the provisions of the MHS bill.

What is "Hearth ProfessionalWork" ?

"Hearth Professional Work" means the installation, replacement, connection, venting, inspection, repair, maintenance, or servicing of:

- Hearth Product Appliances
- Barbecue Appliances
- Outdoor Patio Appliances
- Decorative Space Heater Appliances

Hearth Professional Work Includes:

"Hearth Professional Work" shall include the installation, inspection, repair, or servicing of:

- Vent & Vent Connectors
- Masonry Chimneys
- Metal & Factory Built Chimneys & Vent Systems
- Natural or Manufactured Gas Piping on the load side of the meter.

Who does the law affect?

The MHS Bill affects everyone who installs, replaces, connects inspects, repairs, maintains or services Hearth Products and/or Chimney and Vent Systems in the State of New Jersey.

The MHS bill provides that no person is permitted to work as a MASTER HEARTH SPECIALIST or use the title or designation of "licensed MASTER HEARTH SPECIALIST" or "MASTER HEARTH SPECIALIST" unless licensed pursuant to the provisions of the MHS bill. Furthermore, no provision of the bill is to be construed to prevent any person LICENSED by the State, from acting within the scope of practice of the respective profession or occupation, but no person may advertise, display or use the designation "licensed MASTER HEARTH SPECIALIST" unless licensed as a MASTER HEARTH SPECIALIST under the provisions of the bill.

"MHS" - Licenseing Qualifications:

Every person desiring to apply for a master hearth specialist license who shall meet the qualifications as set forth herein, shall deliver to the MHS Committee/board, personally or by certified mail, return receipt requested, postage prepaid, a certified check or money order payable to the Treasurer of the State of New Jersey in the required amount, together with the written application required by the board, completed as described in the application, and together with proof of qualification as described herein.

- b. the person shall be a citizen or legal resident of the U.S.
- c. the person shall possess a Valid Certification as a Master Hearth Professional, issued by the National Fireplace Institute (NFI)
- d. The person shall have been engaged or employed in hearth professional work for a period of five years preceding the date of the person's application for licensure.
- e. Proof of compliance with the qualifications shall be submitted to the board in writing, sworn to by the applicant and the written proof shall be accompanied by two recent photographs of the applicant.

To Obtain MHP Status you need to be certified in Three (3) Hearth Product Categories Plus the Core.

- NFI Core
- NFI Wood Burning Specialist
- NFI Pellet Specialist
- NFI Gas Specialist

NFI Specialist that have earned all three fuel specific certifications are recognized as "Master Hearth Professionals" (MHP)

Licensed Required to work as a "Hearth Specialist" A person shall not work as a master hearth specialist or use the title or designation of "licensed master hearth specialist" or "master hearth specialist" unless issued a license pursuant to the provisions of this bill.

The "Master Hearth Specialist" Application is Available Online

What to include with your Master Hearth Specialist Application

Every person desiring to apply for a master hearth specialist license who shall meet the qualifications as set forth herein, shall deliver to the Master Hearth Specialist Committee, personally or by certified mail, return receipt requested, postage prepaid, a certified check or money order payable to the Treasurer of the State of New Jersey in the required amount, together with the written application required by the board, completed as described in the application, and together with proof of qualification as described herein.

- The person shall be 21 or more years of age. <u>Deliver to the committee</u> -Copy of Driver's License, Birth Certificate or US Passport.
- 2. The person shall be a citizen or legal resident of the United States. Deliver to the committee -Copy of Birth Certificate or US Passport
- 3. The person shall possess a valid certification as a Master Hearth Professional, issued by the National Fireplace Institute, or an equivalent authority approved by the board. Deliver to the committee -

Copy of your NFI - MHP Identification Card or Certificate

4. The person shall have been engaged or employed in hearth professional work for a period of five years preceding the date of the person's application for license.

<u>Deliver to the committee</u> -Copy of previous (5) years of W2s

5. Proof of compliance with the qualifications shall be: submitted to the board in writing, sworn to by the applicant, and the written proof shall be accompanied by two recent photographs of the applicant.
